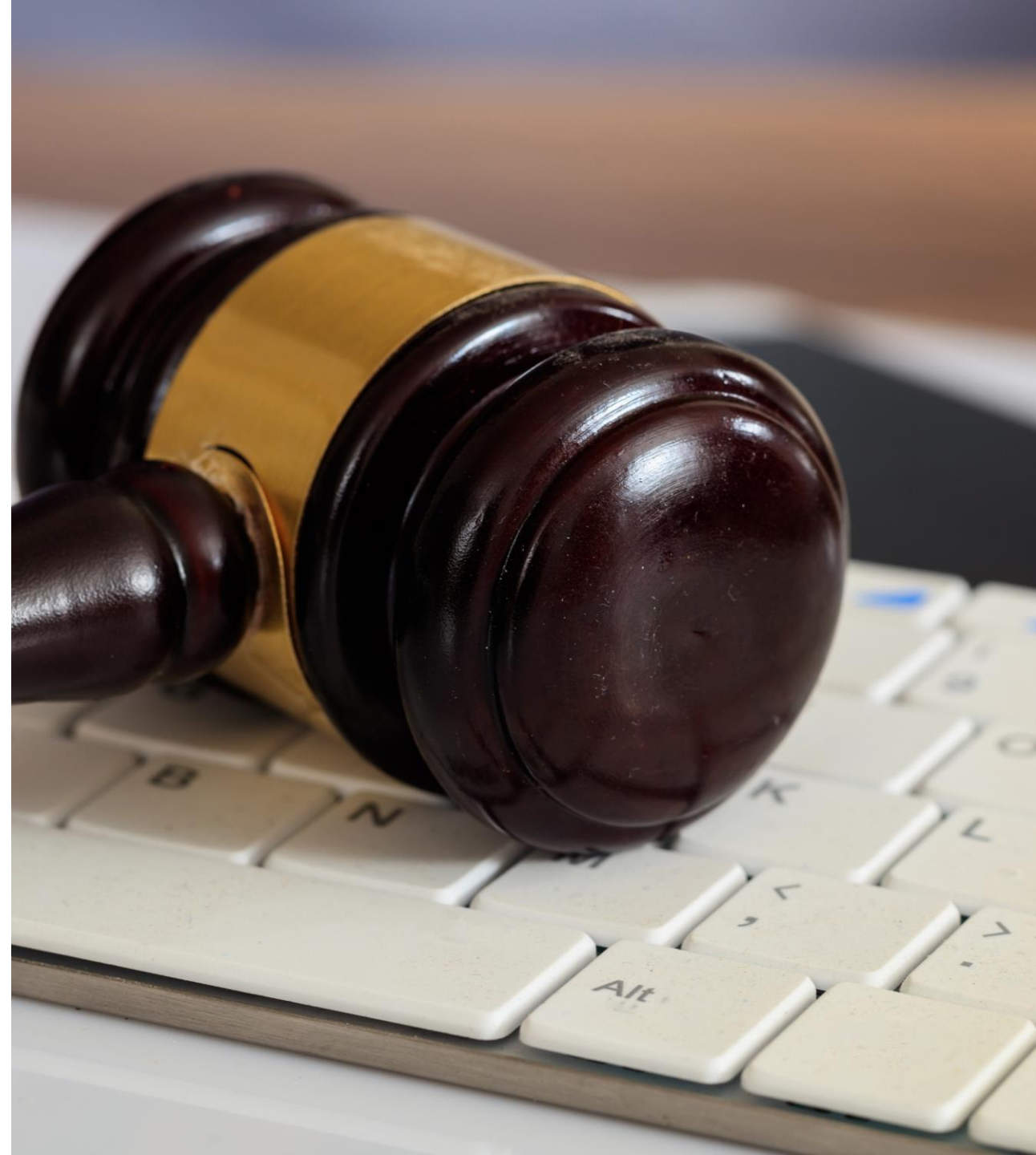

That was when Anastasio Laoutaris, a former IT engineer who worked for the firm for five years, accessed Locke Lord's computer network without authorization and, according to a press release from the U.S. Attorney's office for the Northern District of Texas, "caused significant damage to the network." But the 1,000-lawyer firm was lucky.

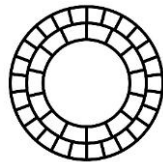
